


REPLAT OF PART OF BLOCK 39 FLEETWOOD ADDITION

KNOW ALL MEN BY THESE PRESENTS THAT WE, THE UNDERSIGNED, BEING THE PRESENT OWNERS OF THE N30' LOT 4, ALL OF LOTS 5 THRU 11, BLOCK 39, FLEETWOOD ADDITION, 3RD FILING, AN ADDITION TO THE CITY ODESSA, ECTOR COUNTY, TEXAS HAVE CAUSED THE SAME TO BE REPLATED AS SHOWN HEREON, AND DO DESIGNATE THE SAME AS THE REPLAT OF PART OF BLOCK 39, FLEETWOOD ADDITION, 3RD FILING, AND DO DEDICATE THE STREETS AND ALLEYS TO THE PUBLIC FOR THEIR USE, BUT IN THE EVENT SAID STREETS AND ALLEYS SHALL CEASE TO BE USED AS SUCH, THE TITLE THERETO SHALL REVERT TO US, OUR HEIRS AND ASSIGNS, AND DO GRANT TO MINERAL LESSEES THE USE OF THE STREETS, AND ALLEYS AS HEREIN DEDICATED FOR RIGHTS OF INGRESS, AND EGRESS FOR LAYING PIPELINES, TELEPHONE, AND TELEGRAPH LINES THEREIN, AND DO FURTHER PROVIDE THAT THE PIPE LINE EASEMENTS IN PUBLIC STREETS AND ALLEYS AND THE EASEMENTS FOR THE ERECTING OF TELEPHONE AND ELECTRIC LINES THEREIN REFERRED TO SHALL EXIST FOR AND INSURE TO THE BENEFIT OF THE MINERAL FEE OWNERS AND ANY SUBSEQUENT HOLDER OF AN OIL, GAS AND MINERAL LEASE, OR A MINERAL LEASEHOLD ESTATE FROM THEM.
