

THAT WE, THE UNDERSIGNED, BEING THE PRESENT OWNERS OF 7.50 ACRES OF LAND IN SECTION 24, BLOCK 42, T-2-S, T. & P. RY. CO. SURVEY, ECTOR COUNTY, TEXAS HAVE CAUSED THE SAME TO BE SUBDIVIDED INTO LOTS, BLOCKS, STREET, AND ALLEY, AND DO HEREBY DESIGNATE SUCH SUBDIVISION "IDLEWILD ESTATES, 2ND FILING" AS SHOWN HEREON, AND DO DEDICATE THE STREET AND ALLEY TO THE PUBLIC FOR THEIR USE, BUT IN THE EVENT SAID STREET AND ALLEY SHALL CEASE TO BE USED AS SUCH, THE TITLE THERE TO SHALL REVERT TO US, OUR HEIRS AND ASSIGNS, AND WE DO FURTHER DEDICATE TO THE GULF OIL CORPORATION ITS SUCCESSORS AND ASSIGNS, EASEMENTS IN AND TO THE STREET AND ALLEY FOR THE PURPOSE OF INSTALLING, MAINTAINING AND OPERATING OIL, GAS, AND WATER LINES, AND TELEPHONE AND ELECTRICAL LINES SO LONG AS SAID GULF OIL CORPORATION ITS SUCCESSORS AND ASSIGNS HOLD OIL AND/OR GAS LEASES ON THE ABOVE DESCRIBED LANDS.
