

KNOW ALL MEN BY THESE PRESENTS: That we, J. B. McCuistion, Jr., and Margaret Joe McCuistion, his wife, being the present owners of Tract #39 of the Lakeview Addition, located in the East 1/2 of Section 4, Block 42, T2S, T & P Survey, Ector County, Texas have caused same to be subdivided into Lots as shown on the annexed plat, and do hereby dedicate the road, as shown, to the public for public use and benefit so long as it shall be used as such, but in event any part or parts of said road cease to be used for public use, the title shall revert to us, our heirs or assigns. Grantors agree not to drill for oil under said road unless same shall be first abandoned by Grantee.
