


Also known as "Greenway Park" Addition LINDBERG — ADDITION

THAT WE, G.F. WADDELL AND WIFE, OMEGA WADDELL, AND R. T. WADDELL AND WIFE, MARY LEE WADDELL BEING THE PRESENT OWNERS OF 24.6 ACRES OF LAND IN SECTION 33, BLOCK 42, TOWNSHIP 2-SOUTH, ECTOR COUNTY, TEXAS, HAVE CAUSED THE SAME TO BE SUBDIVIDED INTO LOTS, BLOCKS, STREETS AND ALLEYS, AS SHOWN, AND HEREBY DESIGNATE SUCH SUBDIVISION AS "LINDBERG ADDITION" AND DEDICATE THE STREETS AND ALLEYS TO THE PUBLIC, BUT IN THE EVENT ALL OR PART OF SAID STREETS AND ALLEYS SHALL CEASE TO BE USED AS SUCH, THE TITLE TO SUCH UNUSED STREETS AND/OR ALLEYS SHALL REVERT TO US, OUR HEIRS AND ASSIGNS.
