


NEWMAN ADDITION

KNOW ALL MEN BY THESE PRESENTS

THAT WE, PAUL E. ARGAUD, EARNEST BROUGHTON, MILTON NEWMAN, BEING THE PRESENT OWNERS OF 10.0 ACRES OF LAND IN THE SOUTHEAST PART OF SECTION 33, AND WE, CARL T. SMITH AND WIFE, JUANITA SMITH, BEING THE OWNERS OF THE SOUTH 2.18 FEET OF A 3.0 ACRE TRACT OF LAND ADJACENT AND BOUNDING THE ARGAUD, BROUGHTON, AND NEWMAN 10.0 ACRE TRACT, DO HEREBY CAUSE THE SAME TO BE SURVEYED AND PLATTED INTO LOTS, BLOCKS, STREETS, AND ALLEYS AS SHOWN ON THE ABOVE PLAT. WE HEREBY DESIGNATE SUCH SUBDIVISION "NEWMAN ADDITION" AND DEDICATE THE STREETS AND ALLEYS, AS SHOWN, TO THE PUBLIC FOR IT'S USES. IN THE EVENT SAID STREETS AND ALLEYS SHALL CEASE TO BE USED AS SUCH, THE TITLE THERETO SHALL REVERT TO US, OUR HEIRS, AND ASSIGNS AND WE HEREBY RETAIN UNTO OURSELVES, OUR HEIRS AND ASSIGNS OUR INTEREST IN ALL THE MINERALS IN OR UNDER SAID STREETS OR ALLEYS.
