

THAT WE, W. R. PETTY AND WIFE, BESSIE E. PETTY, BEING THE PRESENT OWNERS OF PART OF TRACT 51 OF THE GIST SUBDIVISION OF PART OF SECTION 9, BLOCK 42, TOWNSHIP 2-SOUTH, T & P RR CO. SURVEY, ECTOR COUNTY, TEXAS, ALSO KNOWN AS "TEEPEE HEIGHTS" HAVE CAUSED THE SAME TO BE SUBDIVIDED INTO LOTS, BLOCKS, STREETS, AND ALLEYS AND DO HEREBY DESIGNATE SUCH SUBDIVISION "PETTY ADDITION" AS SHOWN HEREON, AND DO HEREBY DEDICATE THE STREETS AND ALLEYS TO THE PUBLIC FOR THEIR USE, BUT IN THE EVENT SAID STREETS AND ALLEYS SHALL CEASE TO BE USED AS SUCH THE TITLE THERETO SHALL REVERT TO US, OUR HEIRS AND ASSIGNS.
