


SMITH - PEARSON ADDITION

EXPLANATION OF REPLATTING

The above platted tracts, excepting Blocks 1 and 2, have in fact been replatted and have been set out on the ground in the positions as shown on the above plat. All of said property was purchased by the First National Bank of San Angelo, Texas, on October 17, 1932, as shown by deed of record in Vol. 36, Page 634, of the Deed Records of Ector County, Texas. The First National Bank of San Angelo, Texas, then shows a replatting of said property in connection with its plat and dedication of Hollywood Gardens Addition, which conformed with the dimensions of the Replat of the North part of Smith-Pearson Addition. Blocks 1 and 2 have never been replatted prior to the replat as above shown. For the purpose of clarifying to the public, I have made the above replat to be placed of record.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being the present owners of all of Block 2 and all of Block 1, except lots 7 & 8 thereof, SMITH-PEARSON ADDITION TO THE CITY OF ODESSA, Ector County, Texas, hereby adopt the replatting of the South Part of said Addition, as above shown, and we hereby dedicate the streets and alleys, as shown on the above and annexed plat, to the Public and for Public use and benefit, so long as they may be used as such, but in the event any part or parts of said streets or alleys shall cease to be used for public purpose, then the title thereto shall revert to the undersigned, their heirs and assigns.
