




GRAPHIC SCALE

THAT SUNSET MEMORIAL GARDENS AND FUNERAL HOME, DOES HEREBY SUBDIVIDE THE REAL PROPERTY DEDICATED STATE OF TEXAS TO CEMETERY PURPOSES AND HEREBY DESIGNATES SAID SUBDIVISION AS BURIAL PROPERTY DESCRIBED AS THE SECOND EXTENSION GARDEN OF DEVOTION BEING SITUATED IN SECTION 20, BLOCK 41, T-2-S, T&P RR CO SURVEY, ECTOR COUNTY, TEXAS, IN SUNSET MEMORIAL GARDENS ADDITION, IN ECTOR COUNTY, TEXAS, AND HEREBY DECLARES THAT SAID PLAT SETS FORTH THE LOCATION AND GIVES THE DIMENSIONS OF THE LOTS AND PLOTS AND UTILITY EASEMENTS CONSISTING FOR THE SAME AND THAT EACH LOT SHALL BE KNOWN AND DESCRIBED BY NUMBER ASSIGNED TO EACH ONE RESPECTIVELY ON SAID PLAT.

SUNSET MEMORIAL GARDENS AND FUNERAL HOME REDEDICATES THE REAL PROPERTY TO BE USED EXCLUSIVELY FOR CEMETERY PURPOSES, INCLUDING ONLY AND ALL PURPOSES NECESSARY OR INCIDENTAL TO ESTABLISHING MANAGING OPERATING, MAINTAINING, IMPROVING OR CONDUCTING A CEMETERY, INTERRING HUMAN REMAINS, INCLUDING CREMATING HUMAN REMAINS OR PRESERVING AND EMBELLISHING CEMETERY PROPERTY.


THE BOARD OF DIRECTORS OF SUNSET MEMORIAL GARDENS AND FUNERAL HOME MAY BY RESOLUTION OR ORDER AND RESERVE AND CHANGE THE SHAPE AND SIZE OF THE REAL PROPERTY AS DEDICATED AND DELINEATED ON THE PLAT ATTACH THAT CHANGE DOES NOT DISTURB ANY INTERRED REMAINS. IF SUCH A CHANGE IS MADE, SUNSET MEMORIAL GARDENS AND FUNERAL HOME SHALL FILE AN AMENDED MAP WITH THE COUNTY CLERK OF ECTOR COUNTY, TEXAS.

THE FORM OF THIS DEDICATION HAS BEEN APPROVED BY THE BOARD OF DIRECTORS OF SUNSET MEMORIAL GARDENS AND FUNERAL HOME AND EXECUTED BY ITS PRESIDENT AND ITS SECRETARY OR ANOTHER PERSON AUTHORIZED BY THE BOARD AND ACKNOWLEDGED.

THE DEDICATION WAS MADE PURSUANT TO SECTION 711034 OF THE TEXAS HEALTH AND SAFETY CODE, AND ITS CONSTRUCTIVE NOTICE OF THE TERMS AND PROVISIONS HEREOF. EXECUTED AND EFFECTIVE THIS 20 DAY OF May, 2008.
