


THAT SUNSET MEMORIAL GARDENS AND FUNERAL HOME, DOES HEREBY SUBDIVIDE THE REAL PROPERTY DEDICATED STATE OF TEXAS TO CEMETERY PURPOSES AND HEREBY DESIGNATES SAID SUBDIVISION AS BURIAL PROPERTY DESCRIBED AS SERENITY CREMATION GARDEN BEING SITUATED IN SECTION 20, BLOCK 41, T-2-S, T&P RR CO SURVEY, ECTOR COUNTY, TEXAS, IN SUNSET MEMORIAL GARDENS ADDITION, IN ECTOR COUNTY, TEXAS, AND HEREBY DECLARES THAT SAID PLAT SETS FORTH THE LOCATION AND GIVES THE DIMENSIONS OF THE LOTS AND PLOTS AND UTILITY EASEMENTS CONSISTING FOR THE SAME AND THAT EACH LOT SHALL BE KNOWN AND DESCRIBED BY NUMBER ASSIGNED TO EACH ONE RESPECTIVELY ON SAID PLAT.

SUNSET MEMORIAL GARDENS AND FUNERAL HOME REDEDICATES THE REAL PROPERTY TO BE USED EXCLUSIVELY FOR CEMETERY PURPOSES, INCLUDING ONLY AND ALL PURPOSES NECESSARY OR INCIDENTAL TO ESTABLISHING MANAGING OPERATING, MAINTAINING, IMPROVING OR CONDUCTING A CEMETERY, INTERRING HUMAN REMAINS, INCLUDING CREMATING HUMAN REMAINS OR PRESERVING AND EMBELLISHING CEMETERY PROPERTY.






