


WEST WADDELL ADDITION

DEDICATION

STATE OF TEXAS: COUNTY OF ECTOR:
KNOW ALL MEN BY THESE PRESENTS: That we, G. F. Waddell, and Omega Waddell, his wife, and R. T. Waddell, and Mary Lee Waddell, his wife, being the present owners of a tract of land located in the Northeast part of Tract 5 and Northwest part of Tract 6, a subdivision of Section 33, T & P Block 42, T 2 S, Ector County, Texas, have caused same to be subdivided into Lots, Blocks, Streets and Alleys as shown on the annexed plat. We hereby dedicate said Streets and Alleys to the Public and for Public use and benefit so long as they are used as such, but in event any part or parts of said Streets and Alleys shall cease to be used for Public purposes, the title shall revert to us, our heirs and assigns. We hereby reserve for ourselves, our heirs, and assigns, all our mineral rights in and under said Streets and Alleys. Grantor covenants and agrees that neither we, nor our heirs or assigns shall ever drill for oil upon said Streets and Alleys unless same shall first be abandoned by Grantee. This tract is not and never has been part of our homestead.
