


YELLOTT ADDITION

THAT WE, THE UNDERSIGNED, BEING THE PRESENT OWNERS OF A 0.48 ACRE TRACT OF LAND IN SECTION 34, BLOCK 42, T-2-S, T&P RR CO SURVEY, ECTOR COUNTY, TEXAS, HAVE CAUSED THE SAME TO BE SUBDIVIDED AS SHOWN ON THE ABOVE PLAT AND DO HEREBY DEDICATE A PORTION OF STREET TO THE PUBLIC FOR ITS USE, BUT IN THE EVENT SAID PORTION OF STREET CEASES TO BE USED AS SUCH THE TITLE THERE TO SHALL REVERT TO US OUR HEIRS AND ASSIGNS AND DO HEREBY DESIGNATE SUCH PLAT AS YELLOTT ADDITION, TO THE CITY OF ODESSA, TEXAS.


